The Toolkit is a set of short guidance, practical tools, and capacity-building packages that provide operational guidance on including children with disabilities in humanitarian action. In accordance with the UNICEF Core Commitments for Children in Humanitarian Action (CCCs), this toolkit provides practical information on how to plan, coordinate, implement, and monitor humanitarian responses that address the needs and priorities of children with disabilities. Training module on including children with disabilities in humanitarian action:
