#### BACKGROUND

Increased food insecurity and wasting due to:

- Covid
- Concurrent drought, climate shocks
- Ukraine- food price crisis

Global Action Plan on Child Wasting and global leadership

- Renewed commitments to increasing the scale of wasting treatment
- Specific wasting technical working groups aimed at examining
  - Simplified approaches, costing, scale, capacity




#### **WASTING PRINCIPLES**

- Scaling up the services for the early detection and treatment of child wasting
- •Supporting the implementation of the existing protocol at scale
- Ensuring access to RUTF and therapeutic milk for SAM and RUSF for MAM
- •Prioritizing RUTF for SAM, but if enough quantity use it for MAM in the absence of RUSF
- Transparent and inclusive discussion consultation of any longer-term shifts concerning national protocol
- Additional support to families and households with wasted children

#### **SUPPLY CHAIN WORK**

- Routine work with suppliers, pricing, ingredients
- Suppliers meeting in August for production scale up
- A coordination is in place between UNICEF and WFP to improve SNF visibility (Dashboard: forecast, demand/capacity)
- Pre- financing arrangement (Gates/UNICEF)

#### **Country update UNICEF: Mali**

#### Implemented/ongoing

- ✓ 105,737 cartons of RUTF purchased, of none received but 24,615 cartons underway and currently at Dakar.
- ✓ The current award will contribute to about 49% of the 2023 RUTF pipeline.
- milk, medicines ✓ Therapeutic and anthropometric equipment procured.
- Establishment of IYCF support groups in Kaye.
- ✓ Support to functioning of mobile clinics in Gao and Tombouctou with NGO IEDA Relief.

#### Moving forward

- Establishment of 2 new partnership agreements with AMCP and World vision international for prevention, early detection and treatment of child wasting at community level.
- Training of community health workers on IYCF.

#### Country update WFP: Niger

#### Implemented/ongoing

- ✓ 163.7 MT of RUSF purchased and on the way.
- ✓ The current award will contribute to about 16% of RUSF pipeline.

#### **Moving forward**

✓ Continuous discussion and coordination with UNICEF on the scale up plan

**Session Title: Wasting Scale Up BHA Nutrition Supplemental Progress Update** 



#### **CHALLENGES**

- Supplier capacity to scale up and have the correct funds/equipment/staffing
- Last mile delivery
- Pre-positioning linked to expanding admission criteria/simplified approaches



#### **LESSONS LEARNED**

- Centralized procurement
- Key to success is joint planning and mapping out coverage
- Forecasting by partners
- Issue of discharge criteria and links between continuum of care
- Agreements between partners and UNICEF and WFP
